1	No bus service Graffiti in bus stops Not enough amenities for secondary aged people Unightly and not fit for purpose noticeboard at the village hall No bike racks Benches in need of repair
2	The farmers have no regard for upkeep of rights of way and it takes the council to visit them and tell them to sort it out
3	The A137 unfortunately has become a useful cut through for motorists avoiding the Copdock interchange, and this leads to the road being far too busy at certain times.
4	Again, mostly leading propositions, to which the only logical answer is "Agree"!
5	Tattingstone has become a free car park for Alton Water visitors wanting to avoid the new pay and display charges on Lemons Hill. The Close in particular becomes a car park for these visitors.
6	There is a need for ALL sections of the village to be connected by footpaths thus properly linking the 3 areas together and providing safe access for all.
7	The road signage referring to a "Clearway" approaching, "and on", "Lemons Hill Bridge" is not clear ..or indeed understood by the majority of motorists, resulting in vehicle parking on said bridge, causing problems.
8	Car parking is a significant problem with visitors to Alton Water choosing to park in residential roads since car parking charges have been introduced.
9	is the road signs question a trick question? It's the opposite way round. Road signs seem fine but I live here so I don't need them.

2. YOUR VIEWS ON THE WEAKNESS/NEGATIVE FEATURES OF OUR VILLAGE Please tell us whether you agree or disagree that these are weaknesses / negative features of our village

10	Verges could be better used to help wildlife and pedestrians in some places. Visibility for traffic and pedestrians is important but most verges do not need more than 1 metre of trimmed edge to provide that. There is a problem with school traffic both in volume and parking provision. Maybe there should be a scheme to provide more car shares or even a minibus. As a pedestrian, the traffic and parking often feels rather unsafe at school start and finish times.
11	The village is obsessed with signage. Dozens between the White Horse and the School, whereas what is actually needed is a footpath.
12	The Clearway signs on Lemon's Hill bridge are barely visible and do not make clear that no parking is allowed on the bridge and either side of it.
13	Parking charges implemented by Alton Water in the small car parks is causing excessive parking congestion on the surrounding roads as people avoid paying. People are also parking along the hill and on sidewalks making it dangerous for pedestrians and reducing visibility for cars travelling through.
14	Anglian Water don't take their responsibilities to the communities surrounding the reservoir seriously.
15	no electric car charging no secure pedestrian walkways
16	Verges and hedges are thrashed and left looking bare and untidy, probably not good habitat for wildlife and thorns are left in the road causing constant punctures in bike tyres.
17	Road signs are not adequate and visible on bridge. A137 at times too high or more it is jammed. Car parking is an issue only as school population out of village and Anglian Water now charge and lock car park.
18	Agree that car parking is a problem on Lemons Hill bridge where parking hinders others to pass - Summer mostly since Anglian Water began car parking charges. Maintenance of verges is a concern on school rd from White Horse end to Lemons bridge. Difficult to walk on verge. There are too many signs, especially near White Horse pub plus the more recent urban Clearway signs ignored by all.
19	Inadequate signs on bridge about parking. Man in a van like giving out tickets thanks to Anglia Water screwing people with parking fees which means you have to pay to take dog for a walk.
20	From Stutton Lane crossing the A137 to reach a pavement is far too dangerous to contemplate.
21	White Horse Hill dead end signs are not clear, often resulting in cars speeding down the hill and parking in the turning areas.
22	Signs to indicate dead end rd- no through traffic often missed and non local traffic come down the hill at speed down White Horse Hill, putting children, dog walkers and pedestrians at risk.
23	Local farmer does a splendid job of hedges etc but it shouldn't be his job! Road signs keep falling down! Or knocked down!
24	Lack of pedestrian footways connecting different parts of the village to encourage walking and cycling e.g. to the school. Junction at A137 at Wheatsheaf needs a roundabout in view of the number of skip lorries to/from Collins and to slow down traffic for The Heath.
25	Most road signs are clear except for those showing on Lemons Hill bridge and its approach. Too much wildlife is killed on A137.
26	No 30 mph restriction sign from Wheatsheaf to school only illuminated sign displaying speed - 'slow' painted on road means nothing.
27	I think it needs to be made clear no parking on Lemons Hill bridge. Not everyone appears to understand the freeway sign.
28	Lack of regular bus service.
29	Non existent bus service. Load bird scared noise from the Glebe Farm during Spring/Summer.
30	Car parking is not a problem throughout the village but in specific areas at specific times of day - year. A. Lemons Hill B. School.
31	Strongly believe that outside village car users ie. Parents from outside Tattlingstone with children at the school should be reminded of speed limits and suitable parking places - not 45mph over Lemons Hill bridge and parking around Badgers Bend. School needs to do more.
32	Occasional anti-social behaviour by the reservoir. Lack of interest by Anglia Water other than fishing in being art of the village community and encouraging volunteers to work on the natural habitat.

2. YOUR VIEWS ON THE WEAKNESS/NEGATIVE FEATURES OF OUR VILLAGE Please tell us whether you agree or disagree that these are weaknesses / negative features of our village

33	Except 30mph sign buried in hedge entering village near White Horse.
34	I think there is very little traffic evident despite our proximity to A137 and Alton Water. That may just be because of our location within the village however.
35	Not many village events encouraging neighbours to meet each other (this maybe because we moved here during Covid.)
36	School needs to sort its parking out, verges being ruined because vehicles cant get by. Public footpaths need maintaining properly.
37	Hedges keep the wildlife safe so I say let them be.
38	Important to keep verges in Summer at Wheatsheaf crossroads and other exits of the village. Can become very dangerous with reduced visibility.
39	Gas cannon bird scarers are ruining the peace and tranquility of a rural location and have impacts on health and well being.
40	It would be nice if weren't on the flight path to Stansted from 4am. Would also be great if the farmers didn't put noisy bird scarers so close to the village houses from dawn to dusk.
41	No shop.
42	Parking has become an issue since Anglian Water started charging for use of their car park. Roads signs not always visible.
43	As I live in a cul de sac I really don't have any knowledge of speeding traffic or volume through the village.
44	Parking only an issue where people are not wanting to pay a charge.
45	Car parking is a problem in some areas, not all. Especially near the school during drop off/pick up - Lemons Hill and The Close.
46	It would be nice if local dog owners used dog poo bags and therefore needed the bins!
47	The new payment meters in Anglia Water car parks have pushed more parking into the village. For example the other Saturday there were 9 cars parked in The Close and 2 in Anglia Water car park.
48	The A137 is still a very fast road and overtaking is a particular concern. Road markings could be altered with an extension of double white lines. The crossroads are another dangerous spot especially at peak times. The number of lorries using the crossroads into the landfill site is another concern.
49	Road signs along A137 between Cragpit farm and Garden House are mostly damaged, non reflective, most of the reflective material has come off. Chevron signs outside Garden House insufficient, very old and poles rotted through. Needs replacement urgently.
50	Road signs at the top of White Horse Hill not adequate. Signs often missed by non local traffic causing traffic to drive downhill at speed.
51	Signs to indicate dead end road on White Horse Hill is not visible enough. Therefore, non locals miss it as a dead end and this causes them to go down the hill at speed causing danger to foot traffic coming up the hill.
52	The general speed of the roads is fine. There are very few speeding offenders.
53	Volume of traffic on A13 may well be too high but I can't hear it from Chedworth Place. Definitely feel speeding is a problem.
54	Speed of traffic on A137 is a 60, everyone drives at 30!
55	The A137 is a huge concern. The speed is also a huge concern. The way people park around the village is irresponsible and disrespectful. A landowner in the village said a dog bin was placed at the entrance of his field with no notification preventing machinery entering the field. Also local residents fill the dog poo bins with their own dog poo from their homes. It should be for dog walkers only.
56	Anglia Water car parking charges and decision to close car parks at 3pm ridiculous. Has caused visitors to park on the side of the road where they like!
57	There needs to be a dog waste bin down the lane that runs parallel to Church Rd near The Heath end. The Clearway signs on the bridge are not clear at all.
58	School pick up times/dangerous speeding around parked cars.

59	Desperately in need of a dog waste bin on The Heath end of Back Lane as lots of dog waste is being left. Clearway signs are Lemons Hill bridge need to be more obvious and clearly marked. Maybe yellow lines.
60	Really could do with speed cameras on A137.
61	Maintenance of hedges/trees on A137 needs attention. Significant number of wing mirrors in the hedges!
62	Dog bins around Alton Water need to be more.
63	No village shop. We have an opportunity to use the existing church for a shop. This makes perfect sense from a church, village and ecological perspective. If the church is not re-ordered it will be closed and be turned into housing.
64	There are too many big trucks in the village and when a diversion happens it is awful with big vehicles speeding around bends.

1	I would support more bulb planting on verges, not sure about tree planting as maintenance could be a problem I would support using part of the playing fields for a small car park More litter picking events
2	There are hardly any bridleways in the village and all it takes it someone to put a DMMO in or the landowner to give permission for it to be changed from a footpath to a bridleway
3	Again, mostly leading propositions, to which the only logical answer is "Agree"!
4	A new village shop would encourage more cars and parking. We already have 2 pubs and a village hall (with limited parking) these should be utilised before building something new.
5	As the WI in Tattlingstone was denied space after extensive investigation for a tree within the village this was a difficult section to answer. The WI tree was planted in Holbrook and now blossoms beautifully for that village to enjoy. How is it possible to consider an orchard when we didn't have room for one tree here in Tattlingstone?
6	Dont be so cynical parish council couldnt find space for a free W I tree in the village it went to Holbrook instead.
7	The community is very adequately supported by a large village hall that has recently been extended further. The village is not populous enough to sustain a village shop as proven by the closure of the previous shop. There are also two pubs in the village. This should be more than sufficient for community activities without converting the church or using green space.
8	Re protecting all open spaces from development. People have to live somewhere but obviously I don't want more houses built near mine. I think the developments along the main road that have filled in gaps seem fine. I would be concerned if we lost the ribbon development character of the village.
9	Current village assets, e.g. the village hall, the church should be utilised before green spaces are built on.
10	Wildlife and biodiversity are already in decline in some ways. We need to be vigilant to protect and augment what we have left. Industrial farming run off from fields is a visible issue most years (blue-green algae in the reservoir. There is also run off of soil from fields due in part to climate change but also to lack of organic matter in the soil (which helps with stability) and frequent ploughing. There is some evidence that farming practices are improving - e.g. more bird seed corridors and some return to organic manure. All green spaces that are not in the existing village envelope should be protected to avoid rampant and unsuitable developments. Footpaths need meaningful and sustainable signs - a countywide problem. Small trees and shrubs would be a good addition to many verges though they should be far away enough from traffic not to create a hazard for motorists or pedestrians. New scrubland and hedges should be positively encouraged. Ideally we would try to have green corridors linking existing woods and wetland areas. The orange lights (sulphur) on the bridge past midnight seem to be a poor choice for keeping a dark sky in the village.
11	The 'village shop' should have proof of demand sorted before anything else. Stutton had a shop for ages before it built premises. Where is the sustainable demand and volunteers for a shop in tattlingstone?
12	There are existing spaces available that can be used for the community's needs, such as a village shop, which would not require the use and destruction of existing green spaces. Viable options using existing structures should be prioritised over using green spaces to develop new structures.
13	Where footpaths cross fields the farmers don't always maintain the footpaths as they are supposed to.
14	Re tree and bulb planting - I agree with this but also see my comment on the footpaths where this may conflict if the verges are used for a footpath.
15	Light pollution is relatively low but some residents leave lights on outside their houses all light long. Meaning that our view of the stars is limited and light shines into our bedroom all night long. We like living somewhere with no street lights and would like a dark bedroom at night.

27	The village infrastructure is at its limit currently, and any added resources such as expanding village hall and a new shop should use existing buildings ie the church.
28	Very important to keep the green, open spaces for the pleasure of all.
29	I think the clothing bank needs to be emptied more frequently or another one added.
30	Whilst the reservoir etc provides a very desirable environment in which to live, and should be maintained where possible, I believe that we cannot - should not adopt a 'NIMBY' approach with the changing needs of the wider community/housing new types of energy etc.
31	A new village hall that is a more fitting building than a glorified portacabin would be welcome.
32	If development brings benefits to the village then I think it should be considered.
33	No more houses needed in Tattingsstone.
34	Not all changes are good. No more building homes in the village.
35	Shop not in church.
36	Shop not in the church.
37	Community orchard sounds like a great idea.
38	A lot of the bridleways were interrupted by the reservoir and not re-instated. The bridleway from village to Cox Hill is impassable.
39	School road between White Horse and Lemons Hill bridge needs a footpath/pedestrian walkway.
40	Green space should not be allowed for development of any kind. Once started it cannot be stopped and we soon become a suburb of Ipswich. We must treasure our dark skies buy everyone a torch!
41	Community orchard would be good but requires suitable space.
42	Protection of birds from bird scarer
43	Sufficient recycling facilities already. We already have church and village hall. The church not being used to its full potential so further development of green spaces would be unnecessary.
44	We already have a village hall and a shop proposal.

20	I think the section of roadside from the school towards the village hall and beyond towards Lemons Hill is dangerous at school closing time.
21	Lack of pavement between Lemons Hill and White Horse very dangerous. Parking on pavements near Lemons Hill by those unwilling to pay car park charges a problem for pushchairs and wheelchairs.
22	Footpaths across farmland on working farms will never be suitable for disabled users I'm afraid, not because of the width allocated but because of the underfoot conditions of walking over a field especially a ploughed one.
23	Bike racks a good idea if we get a village shop.
24	I work in Ipswich town. If there were dedicated cycle lanes between here and there I would probably cycle to work. I feel that the A137 is too dangerous to cycle on.
25	Lemons Hill and the road up to the White Horse is quite dangerous to pedestrians.
26	Roads are not wide enough for cycle lanes. Why would you need bicycle racks.
27	Keep the village as a village we don't need to bike lines. Leave things alone.

1	I have seen evidence of antisocial behaviour, but cannot comment on it being committed by a tourist or resident
2	Alton water visitors with bikes, cars, fishing gear and children park in residential areas instead of the pay and display car parks. They park on pavements and too close the junctions causing congestion and additional noise within quieter residential areas.
3	Anti-social behaviour is intermittent apart from littering which is quite prolific at times and fairly constant. I would like to see schools tackling the issue throughout the school ages. I don't know if that happens but I suspect not. More bins might help.
4	We still see the occasional group of teenagers jumping off Lemons Hill Bridge on hot days. Anything else to discourage this would be appreciated.
5	As above, i suspect that the unnecessary clearway, which increased signage in the village will now lead, inevitably, to more signage.
6	The Clearway is adequately signposted but the meaning of it is not understood by many drivers. IBC patrol regularly and issue CPE tickets to those who fail to park appropriately.
7	There has been some anti-social behaviour particularly related to Alton Water e.g. gatherings of large groups, cars parked across footpaths forcing wheelchair users and people with children in buggies to walk in the road.
8	I don't know what a clearway is.
9	The levels of rubbish thrown into verges and ditches is increasing; comment made by someone who regularly collects and disposes of it. Bins will not resolve this as its clearly just thrown from moving vehicles and sadly predominantly takes the form of drinks, particularly alcohol, containers.
10	The clearway is obstructed by parked cars preventing wheelchair access on the footpaths. It needs to be supervised. Not sure the village website would be visited to find out about parking. It is outrageous that Alton Water are charging so much for even a short parking period. The early gate lock renders the carpark nearly redundant
11	The original reason for Clearway has meant no more people jumping off the bridge. Covid has meant more parking as people don't know or see Clearway signs. A simple no parking fine would work. Anti-social behaviour has decreased in some respects due to Covid.
12	The Clearway around Lemons Hill bridge needs monitoring. Penalties for those not adhering to. Littering got worse post Covid. Parking information - who are we hoping to inform this way.
13	I feel an increase in tourism has led to more litter.

23	More benches are only good if maintained. How many more signs do we require, we are a village not a town suburb.
24	If we want a village shop/cafe we should be openly supportive of visitors to Alton Water/the village for it to succeed.
25	Lockdown proved what a nightmare it was everyone coming here.
26	Rubbish being left around Alton Water is a lack of respect for our village.
27	Parking on Lemons Hill bridge is a particular problem. Today as I drove out of the village 5 cars were parked on the bridge edge and 4 on the way back two hours later.
28	This needs to be carefully looked at and controlled.
29	Refer above. Benches should be funded for residents benefit not visitors! Perhaps giving residents and opportunity to purchase as 'in memory'.
30	All is being done already.
31	By charging for parking and early closing has caused vehicles to be parked on Lemons Hill and around the village.
32	The idea that tourism has led to anti-social behaviour is anarchic and prejudice. The promotion of our village will only service for good in the village.

1	In place of more outdoor play equipment, I would like to see outdoor gym equipment for use of residents from 11 years up More pro-activity from village hall and playing field committee to communicate with residents to establish how to best use hall and playing field to benefit all Village hall ceiling and noticeboard needs repairing
2	The village is getting more and more young people in the village and the old are either leaving or sadly dying so the church is getting less and less visitors so it needs to get totally repurposed to suit the younger generation (teenagers 13-18)
3	I do not want to see the Church being used for commercial usage, I understand that some people want a shop or a Cafe, but think this should not be in the Church. Why could it not be in the Cricket pavilion?
4	We do not need a new cafe/ shop when there are 2 pubs and a village hall that already offer community meeting spaces, all of these already have car parking provided. The church should not be torn apart to accommodate an unnecessary cafe.
5	A community shop would benefit the community but not necessarily in the church as parking would be a challenge and pavements to allow pedestrian access from all parts of the village are not available.
6	Full fibre broadband is already available in the village
7	The concept of a Community Shop located within the Church is an idea that the village proposed to the Church. Consequently the Church should not expect the village to pay or raise finance for any new facilities such as parking or toilets. These should be the responsibility of the Church and should be in place already anyway for it's congregation. The Church should not benefit in anyway financially from a Community Shop because the Church of England is financially well off (£9 billion endowment generating over £2 billion per annum). If the Church of England cannot encourage greater congregation sizes, pay for the up keep and maintenance of its historic buildings they should be 'closed' to worship and be offered to the Parish/Village to use as they see fit. If the Church was led and governed by those with a forward thinking and innovative leadership they would have proposed the Community Shop themselves and thus be fully entitled to benefit from any success, they did not and thus should not benefit. If the Church is financially unviable, then like any business it should close. The Church in rural areas has a propensity to be set in aspic, revered by the elderly searching for solace and ignored by the young except for the 'Selfie Shots' at one-off events (weddings, christening etc). Any campaign that offers alternative solutions or proposals but comes with potential 'strings' or 'quid pro quo' arrangements should be considered and then decided upon in an open and free manner before being dismissed. As a compromise the Community Shop might be in a position to pay a 'peppercorn' rent. All of the above is based on the Community Shop being a viable proposition, yet to be proven anyway and in the long term fraught with financial uncertainty, the Parish/Village therefore should be very careful committing Parish/Village finances to a project that is potentially unviable.
8	The community has a large village hall and 2 pubs to use for community activities, socialising and to get refreshments. The Church has no car parking facilities and being next door to a school will only cause more congestion and parking problems to the village on top of the tourists parking following Anglian Waters decision to charge for parking.

I am not convinced that St. Marys can be re-ordered to incorporate all the aspects of a shop, cafe and church without additional space or provision of toilet/bathroom facilities etc.
11	Car parking outside the church is problematic (visitors to Alton Water as well as parents). Lemon's Hill bridge is very shabby and gives a poor impression of the village. Allowing a village shop and cafe while also improving the space for worship would benefit the entire village.

14	There is no public transport to our nearest compulsory post 16 education provider (suffolk one) meaning I have had to change my work hours and earn less in order to take my sons to school, holding back my career and work opportunities for the four years they have to attend. It's still cheaper to lose wages than to pay the overpriced bus that was not timed to match college times and was provided for one term then cancelled. I would love to have a reason to go into our church without feeling hypocritical. I feel it's use for the wider community would enrich our village, provide a much needed social hub for people during the day, with a focus other than alcohol or for those who don't feel welcome or comfortable in our pubs.

1	This is an impossible question to answer without knowing how many young people in the village would like to remain living there when they leave home. Not many, I suspect.
2	We should grant selective planning permission where possible in order to link up the village, ie hill and church rd to the heath. Unless we provide housing for the young the village will die.
3	Steeple Aston Oxfordshire had a scheme attached to a development that required the houses to be offered to people with family eg parents living in the village. I am more in favour of development if it has these sort of conditions. I realise that the increase in the value of my house has priced out some people who deserve to live here because their roots are here.
4	More people to use community facilities = the facilities are more viable.
5	Obviously any new housing should hit some or all the targets in 9. above. Just because I'm unsure of the need does not mean I don't want to express an opinion on the provision as it is important for the future integrity of the village as a community.
6	Tattingstone having failed to cut a deal with the local landowner when they wanted to put an admirable solar park on their land and simply opposed it, means I cannot see how the village could cut a deal to provide 'community improvements' in exchange for further housing developments. But personally I would swap some housing dev for proper footpaths that allow people to walk and cycle uninterrupted from one end of the village to the other.
7	Affordable housing for young people is a thing of the past. Housing is not affordable for our young people and becoming less and less possible. Developers seem intent on building huge houses that no young person will ever be able to afford. Our young people will be forced out of the village.
8	I come from West Mersea where massive overdevelopment has destroyed the traditional community and way of life and has brought very few, if any advantages. Almost no open spaces exist away from the coastline, and wildlife has disappeared. We do not want every village in Suffolk become an extension of suburbia, but this is already happening in many locations. Let's try to keep Tattingstone a village.
9	If young families are priced out of the village the primary school will die. A village full of wealthy, old second homes does not create a good community. Villages come alive with children and young families.
10	Housing needs to be affordable to locals and with gardens. Green spaces within housing is important.
11	There is no infrastructure for more housing and roads etc wouldn't cope.
12	This is a big issue needing a much wider debate and analysis eg. poor transport reduces the potential for older people to retire here and so generate more retirement housing.
13	Community feel of Tattingstone could be improved by sympathetic development along the road between The Heath and Church/School parts of the village.
14	Affordable housing that village local/village young people have priority for.
